FFGL Privacy Policy

This is the privacy policy ("**Privacy Policy**") of Freedom Foods Group Limited (A.C.N 002 814 235), Nutrition Ventures Pty Limited (A.C.N 089 982 392), Nutrition Ventures Financing Pty Limited (A.C.N 127 100 387), Paramount Seafoods Pty Limited (A.C.N 070 130 120), Freedom Foods Pty Limited (A.C.N 068 972 181), Australian Natural Foods Holdings Pty Limited (A.C.N. 109 854 373), Thorpedo Foods Pty Limited (A.C.N 109 219 918), Thorpedo Seafoods Pty Limited (A.C.N. 111 860 550), Pactum Australia (A.C.N 112 913 336) and Thorpedo Foods Group Pty Limited (A.C.N 109 219 918) (collectively referred to as "**FFGL**").

Each member of the FFGL is committed to ensuring that it complies with the provisions of the Privacy Act 1988 in dealing with your personal information.

This Privacy Policy sets out how the FFGL will deal with your personal information.

Collection of your personal information

Each member of the FFGL only collect personal information which it believes is necessary to:

- (a) conduct its business;
- (b) provide its goods and services to you or information about its goods or services to you;
- (c) when you contact it by email to give it feedback or submit an enquiry.

FFGL may also use your personal information to market products and services to you or to inform you of any special offers, discounts or other information which are considered to be of interest to you. However, if you do not wish to receive future marketing, promotional or sales material from FFGL, you may contact the FFGL at any time by sending an email to info@ffgl.com.au requesting that no further material be sent to you. FFGL will, as soon as reasonably practicable after receiving your request, remove your contact details from its marketing database.

The type of personal information collected by the FFGL includes your name, street address, telephone number, facsimile number and email address.

When you use the website of a member of the FFGL, that member will generally only collect personal information from you which are provided by you; for example, when you request information about that member's products and services.

The Internet service provider (ISP) used by the FFGL makes a record of all your visits to a member's site and logs a variety of information for statistical purposes only; for example, your server address, your domain name, and the date and time of your visit to the relevant site. The FFGL ISP also collects information such as the pages accessed and documents downloaded, links from other sites followed to reach a member's site, and the type of browser used. This information is anonymous and is only used for statistical and site development purposes. No attempt will be made to identify you or your browsing activities except where required by law.

A member of the FFGL will only record your email address if you send that member a message. The address will only be used for the purpose for which it has been provided to that member by you.

Where lawful and practical, you may interact with a member of the FFGL anonymously.

Use and disclosure of personal information

In general, your personal information is only used for the purposes for which it is collected. For example:

- (a) to enable the FFGL to provide and market its goods and services to you;
- (b) to enhance and develop the FFGL's business relationship with you in relation to goods or services that it provides to you;

or for a secondary purpose related to the primary purpose in relation to which you would reasonably expect your personal information to be used.

FFGL does not transfer your personal information overseas.

Correction of your personal information

The FFGL takes all reasonable steps to monitor that the personal information collected by it is accurate, complete and current. If you think that any of the information that the FFGL hold about you is inaccurate or incomplete, please contact the FFGL by emailing it at info@ffgl.com.au and it will take steps to correct it.

Security of your personal information

You acknowledge that no data transmission over the Internet is totally secure. Accordingly, the FFGL does not warrant the security of any information which you transmit to it. Any information which you transmit to the FFGL is transmitted at your own risk. However, once the FFGL receives your transmission, it will take all reasonable steps to protect your personal information from misuse, loss or unauthorised access using a variety of physical and electronic security measures including access locks and computer and network security.

Access to your personal information

Upon request, you may have access to the personal information which the FFGL holds about you except where access may be denied under the Privacy Act. These circumstances include:

- where providing access would have an unreasonable impact on the privacy of an individual;
- your request for access is frivolous or vexatious;
- where the information relates to current legal proceedings between the FFGL and you;
- where it would be unlawful to provide access or granting such access may prejudice an investigation of possible unlawful activity or enforcement of laws, or where denying access is authorised by law.

To request access to your personal information, please contact the FFGL's privacy officer ("**Privacy Officer**") whose contact details are set out at the end of this Privacy Policy. The Privacy Officer or a delegate will endeavour to respond to your request for access to your personal information within 7 days of the date of receipt of such request.

If your request for access is denied, FFGL will provide you with reasons for its decision.

If your request for access is granted, the FFGL reserve the right to charge a fee for any costs incurred in providing your personal information such as photocopying and postage.

Changes to Privacy Policy

FFGL reserves the right to change its Privacy Policy from time to time by posting such changes on the website of any member of the FFGL. Changes will be effective immediately upon notification on any member of the FFGL's website. Your continued use of any member of the FFGL's website following notification will constitute your acceptance of those changes.
